## Daily Net Tangible Asset (NTA) Update

During the week prior to expiry of the PGFO Options on 30 June 3015, PGF will be providing a daily NTA update.

PGF provides below its daily NTA update as at Wednesday, 24 June 2015.

Approximate NTA before tax on unrealised gains	\$1.2385
Approximate NTA after tax	\$1.1791

As at 24 June 2015, the NTA before any tax accrual was approximately \$1.2687 per share. After the accrual of tax on realised gains (but before tax on any unrealised gains), the approximate NTA was \$1.2385 per share as shown in the table above.

Note that no adjustments are made for future exercise of outstanding PGFO options (exercise price \$1.00 per option) in the table above. The NTA after tax accrual on realised gains, but before tax accrual on unrealised gains would have been approximately \$1.1686 (and \$1.1266 after all tax accruals) if all of the PGFO options had been exercised on Wednesday, 24 June 2015.

As at Wednesday 24 June 2015, 71,865,141 of the initial 173,672,200 option issued by the Company as part of its IPO had been exercised.
