This SPDS supplements the UBS Capped Self Funding Instalments Product Disclosure Statement dated 23 May 2011 ("PDS"), and along with the PDS, sets out the terms of issue of a number of Series of UBS Capped Self Funding Instalments collectively referred to in this SPDS as "UBS Market Growth Instalments". You should read this SPDS together with the PDS and the supplementary product disclosure statements for UBS Capped Self Funding Instalments dated 4 June 2015, 17 June 2013 and 3 May 2013. Words defined in the PDS have the same meaning in this SPDS.

Each Instalment will commence trading with the Expected Loan Amount (after addition of Interest Amount) from 1 July 2015.
