# Completion of Marketboomer divestment and selective share buy-back and option cancellation

Collaborate Corporation Limited (**Collaborate** or the **Company**) (ASX: **CL8**) advises that it has today completed the selective share buy-back of 80,337,670 fully paid ordinary shares and cancellation of 8,033,764 listed options exercisable at \$0.02 each with an expiry date of 30 April 2017 in consideration for the divestment of the Company's 43.3% interest in Marketboomer Holdings Pty Ltd, which owns the Marketboomer business. The share buy-back and option cancellation in consideration for the Marketboomer divestment were approved by shareholders at the Extraordinary General Meeting held on 5 June 2015.

An Appendix 3F and ASIC Form 484 in respect of the share buy-back follows this announcement.

The Directors are pleased to now focus 100% of the Company's resources on collaborative consumption opportunities, leveraging its Peerpass trust and reputation platform to grow a verified, high value customer base and launch into new product categories. The Directors look forward to providing further updates on the Company's progress and strategies in the coming months.

## Repayment of convertible note facility

Collaborate advises that it has repaid the convertible note facility of \$75,000 in June 2015.
