### GALILEO JAPAN TRUST SUCCESSFUL COMPLETION OF ON-MARKET BUY-BACK

Galileo Japan Funds Management Limited ("GJFML"), as responsible entity of Galileo Japan Trust (ASX: GJT) provides the following update relating to the on-market buy-back of GJT units announced to the ASX on 12 December 2014.

GJFML is pleased to confirm the on-market buy-back is now complete. A total of 1,059,250 GJT units have been bought back at an average price of \$1.79 and for total consideration of \$1,899,873.23.

Since the previous notification of the cancellation of securities on 2 June 2015, a further 432,343 units have been cancelled.

Following the successful completion of the buy-back, there are 105,385,415, units on issue.
