Net Tangible Asset Backing

Hunter Hall Global Value Limited (**HHV**) refers to its ASX announcements on its net tangible asset backing (**NTA**) made between 10 September 2014 and 1 July 2015 (inclusive) (for the NTA as at the dates between 5 September 2014 and 26 June 2015 (inclusive), (**NTA Announcements**).

The Board advises that a deferred income tax liability on unrealised gains was not included in the post-tax NTA figures reported in the NTA Announcements, meaning the post-tax NTA figures reported in those announcements were overstated by between 0.4% and 5.1%. The differences between the reported post-tax NTA figures and the post-tax NTA figures corrected to include the deferred income tax liability are set out in Annexure A.

In addition, the Board wishes to clarify that the NTA figures for 31 December 2014 and 20 February 2015 used in HHV's Appendix 4D, 31 December Half-Year Financial Report and the accompanying ASX announcement and half year results presentation (announced to the ASX on 26 February 2015) are the pre-tax NTA figures. The corrected post-tax NTA figures for 31 December 2014 and 20 February 2015 are as set out in Annexure A.

The Board does not consider the differences in the reported post-tax NTA figures and the corrected post-tax NTA figures to be material to investors but considers that it is appropriate to correct HHV's NTA Announcements.
