ASX ANNOUNCEMENT

Option cancellation and issue

The Company has cancelled a surplus option series, currently unlisted, exercisable at \$0.015 and expiring in 2016, reducing administration overheads, and has issued the unlisted option holders with the equivalent number of listed options exercisable at the same price (\$0.015) and expiring on 21 July 2016. As a result the Company now has on issue only one series of options exercisable at \$0.015, all of which are listed."
