#### Report on Activities and Appendix 5B - June Quarter 2015

The Company provides the following report on activities for the three month period ended 30th June 2015.

During the quarter, the Company has continued to actively identifying a range of new opportunities, which may well include opportunities beyond the Company's traditional resource sector. We are currently reviewing and assessing those opportunities.

The Company has also been approached by a number of parties seeking investments from the Company.

Exploration activities in Chile have ceased, while operational and administrative overheads have been reduced. Re-habilitation of our previously held concessions has commenced.

#### Corporate

On 9<sup>th</sup> and 10<sup>th</sup> of April the Company raised \$220,000 through the issue of shares to a sophisticated investor and the Company is in the process of raising further equity capital.

On 5<sup>th</sup> June, Mr. William Ji resigned as a Non-executive Director. Mr. David Yu was appointed as a Non-Executive Director on 25<sup>th</sup> June.

#### Sale of the Aguas Claras Land

The sale of the Aguas Claras land was finalized during the quarter. The net proceeds, before relevant taxes, from the sale of the land was 160 million Chilean Pesos (approximately A\$327,000) and this amount was received on 1st July 2015.
