## CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Convergent Minerals Limited refers to the issue of shares on 12 August 2015 by way of a placement to professional and sophisticated investors at \$0.0075 per share and hereby notifies ASX under section 708A(5)(e) of the Corporations Act 2001 (Act) that:

    - B. the rights and liabilities attaching to the shares.
