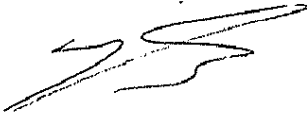

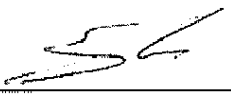

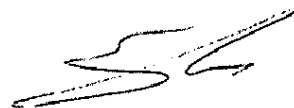

As a consequence, Edgbaston's aggregate ownership fell to a 4.99% level based on the total voting shares outstanding in Cabcharge Australia Limited (being 120,430,683).
