2015 FINAL FULLY FRANKED DIVIDEND OF 2 CENTS PER SHARE AND DIVIDEND REINVESTMENT PLAN

The Board of Desane Group Holdings Limited ("Desane") is pleased to announce that it has declared an ordinary final fully franked dividend of 2 cents per share ("Final Dividend").

The Final Dividend is possible due to the strong financial position of the Company. The **Record Date** for the Final Dividend is **Thursday, 12 November 2015** and the **Final Dividend** will be paid on **Thursday, 26 November 2015**.

In addition, the Board has resolved to continue the operation of the **Desane Dividend Reinvestment Plan** ("**DRP**") which will apply to the Final Dividend. The DRP provides eligible shareholders (shareholders with a registered address in Australia or New Zealand only) with the opportunity to reinvest all or part of their Final Dividend entitlement in Desane shares, free of any transaction costs. The DRP Information Booklet can be obtained from Desane's website, http://www.desane.com.au/investors/ or by contacting Computershare Investor Services Pty Limited by telephone on 1300 556 161 (within Australia) or 61 3 9415 4000 (international).

Eligible shareholders who have not previously elected to participate in the DRP and who now wish to participate in the DRP with respect to the Final Dividend, must complete the DRP Election form according to the instructions on the form and return it to the share registry **OR** register their election to participate in the DRP online, at www.computershare.com.au/easyupdate/dgh.

In accordance with the DRP Rules, the Board has determined that any shares issued pursuant to the DRP will be issued at the volume weighted average market price of Desane shares during the five trading days subsequent to and inclusive of the ex-dividend date (see table below). No discount has been provided in regards to the DRP issue price.



The timetable for the Final Dividend is as follows:

Last date for receipt of DRP Election forms for Final Dividend	Monday, 16 November 2015
