Multiplex European Property Fund (ASX: MUE) Request for Trading Halt

Pursuant to Listing Rule 17.1 Brookfield Capital Management Limited (**BCML**) the Responsible Entity for Multiplex European Property Fund (**Fund**) requests that the ASX grants a trading halt pending receiving independent advice following receipt of correspondence from the German Tax Office in relation to the tax affairs of the Fund's German subsidiaries.

It is expected that the trading halt will remain in place until the update is announced or the commencement of trading on 28 August 2015, whichever occurs sooner.

BCML confirms that it is not aware of any reason why the trading halt should not be granted.
