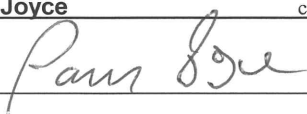

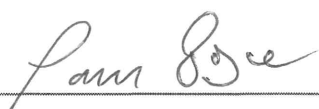

DIRECTIONS
