The issue of shares under the PSR plan was approved by the Board on 16 July 2012.

(g)	Reason for issue	Employees cancelling options issued under the 2010, 2011 and 2012 issues of the Fisher & Paykel Healthcare 2003 Share Option Plan. 99,883 options were cancelled on 3 September 2015 pursuant to the Cancellation Offer approved by shareholders at the ASM held on 12 August 2004. 65,499 shares were issued in consideration of the cancellation of the options and are equal in value to the gain on the options (such gain being calculated based on exercise prices of \$3.37, \$3.53, \$2.36 and \$2.06). 2,500 shares were issued to employees exercising options issued under the 2012 issue of the Fisher & Paykel Healthcare 2003 Share Option Plan based on an exercise price of \$2.06. Employees exercising PSRs issued under the 2012 issue of the Fisher & Paykel Healthcare Performance Share Rights Plan. 115,510 PSRs were exercised on 3 September 2015, and 115,510 shares were issued.
