### **Kookaburra Gully's graphite Mining Lease Proposal for SA's Eyre Peninsula available for public comment**

Graphite developer, Lincoln Minerals Limited (ASX:LML) ("Lincoln" or "the Company") is pleased to advise that the proposal by its wholly-owned subsidiary Australian Graphite Pty Ltd for a Mining Lease over its Kookaburra Gully graphite project has today been made available for public comment by the South Australian Department of State Development (DSD).

The Kookaburra Gully graphite project is located 35 kilometres north of Port Lincoln on South Australia's Eyre Peninsula.

The mining lease proposal (MLP) is for a conventional open pit mining operation with associated processing plant to upgrade graphite ore into high grade graphite concentrate at a rate of ~25,000-55,000 tonnes per annum. Kookaburra Gully is one of Australia's premier graphite deposits with total current Indicated and Inferred Mineral Resources of 2.20 million tonnes grading an average 15.1% TGC (Total Graphitic Carbon) (*Lincoln Minerals Limited, ASX release 19 December 2013*).

It ranks in the world's Top 10 graphite deposits based on grade and is close to water, electricity and an export port 35kms away.

The MLP is open for public submissions until 29 October 2015.

The MLP and Mining Lease Application are in the name of Australian Graphite Pty Ltd (AGL). AGL is referred to in all of the application documentation relating to the proposed Kookaburra Gully graphite project. This will not impact or change any commitments that Lincoln has made with the community during the consultation period for the MLP and which are endorsed and will be adopted by AGL.
