## Appendix 4C Quarterly Cash Flow Report 30 September 2015

**14 October 2015 – Sydney, Australia & Auckland, New Zealand** – Living Cell Technologies Limited today released its cash flow report for the quarter ended 30 September 2015. The Appendix 4C is attached. The company ended the quarter with a cash balance of \$4,506,731 compared to \$5,144,026 in the previous quarter. The decrease is due to normal operating costs, continuing to monitor clinical trial patients and preparing for the Phase IIb clinical trial of NTCELL<sup>®</sup> for the treatment of Parkinson's disease following the successful outcome of the Phase I/IIa clinical trial published in June.

Net operating cash flow in the quarter was \$(695,917) compared to \$(1,320,618) in the previous quarter. Receipts from customers were \$8,366 (previous quarter \$175,186) reflecting the wind down of services provided to the joint venture company. Operating payments were \$738,846 compared to \$1,620,882 in the previous quarter. This decrease is primarily due to the absence of PET scanning of the last two patients and reduced clinical trial monitoring costs.

Living Cell Technologies Limited (LCT) is an Australasian biotechnology company improving the wellbeing of people with serious diseases worldwide by discovering, developing and commercialising regenerative treatments which restore function using naturally occurring cells.

LCT's lead product NTCELL<sup>®</sup> is an alginate coated capsule containing clusters of neonatal porcine choroid plexus cells. After transplantation NTCELL functions as a biological factory producing factors to promote new central nervous system growth and repair disease induced nerve degeneration.

The Phase I/IIa NTCELL clinical trial in New Zealand for the treatment of Parkinson's disease met the primary endpoint of safety and showed encouraging clinical efficacy improvements. Results from this trial will be used to design a larger Phase IIb trial to evaluate its potential as a disease-modifying

treatment for patients with Parkinson's disease. It has the potential to be used in a number of other central nervous system indications such as Huntington's, Alzheimer's and motor neurone diseases.

LCT's proprietary encapsulation technology, IMMUPEL™, allows cell therapies to be used without the need for co-treatment with drugs that suppress the immune system.

LCT holds a 50% interest in Diatranz Otsuka Limited which is developing a cell therapy for type 1 diabetes.

LCT is listed on the Australian (ASX: LCT) and US (OTCQX: LVCLY) stock exchanges. The company is incorporated in Australia, with its operations based in New Zealand.
