Approval under Listing Rule 10.1 for the grant of security to Mitchell Group 'That for the purposes of Listing Rule 10.1 and for all other purposes, Shareholders approve the grant of a general security agreement over all of Notch No. 2 Pty Ltd's right, title and interest in all of the assets held by Notch No. 2 Pty Ltd to Mitchell Family Investments (Qld) Pty Ltd as trustee for the Mitchell Family Investment Trust (hereafter Mitchell Group) as security for the advance of \$3.5 million by Mitchell Group to Notch (hereafter Mitchell Group Loan).'

Approval of issue of shares to Mitchell Group under Listing Rule 10.11 'That for the purposes of Listing Rule 10.11, Shareholders approve the issue of 20,588,235 Shares to Mitchell Group at an issue price of \$0.017 in lieu of payment of the first year's interest on the Mitchell Group Loan and \$350,000 worth of Shares at an issue price equal to the volume weighted average price for the 30 trading days prior to the issue on 6 July 2016, up to a maximum of 70,000,000 Shares in lieu of payment of the second year's interest on the Mitchell Group Loan, as detailed in the Explanatory Memorandum'

5. Approval of additional 10% capacity under Listing Rule 7.1A

'That pursuant to and in accordance with Listing Rule 7.1A, and for all other purposes, the Shareholders approve the Company having the additional capacity to issue equity securities up to 10% of the issued capital of the Company (at the time of issue) calculated in accordance with the formula prescribed in Listing Rule 7.2A.2, over a 12 month period from the date of this annual general meeting (or until a transaction under Listing Rule 11.1.2 or 11.2 is approved by Shareholders).'
