### **Placement**

Goldsearch Limited (ASX:GSE) is pleased to announce that it has completed a small placement of 733,334 fully paid ordinary shares to sophisticated or professional investors at \$.075 per share to raise a total of \$55,000.

450,753 shares were placed using the Company's remaining capacity under Listing Rule 7.1. and the remaining 282,581 shares were placed utilising the Company's capacity under Listing Rule 7.1A. The dilution to existing shareholders from the issue under Listing Rule 7.1A. is 2.41%.

The Company elected to place the Shares under Listing Rule 7.1A and not as a pro-rata issue or other type of issue that would have allowed current shareholders to be eligible to participate in the issue as it was a small issue and it allowed the Company to complete the capital raise in a timely and cost effective manner.

There were no underwriting arrangements for this issue. There was an 8% placement fee for the issue.
