#### RESIGNATION OF DIRECTORS (EILEEN DOYLE & PETER RICHARDS)

Bradken confirms that Dr Eileen Doyle and Mr Peter Richards have today advised the Bradken Board of their immediate resignation as directors of Bradken Limited.

Accordingly, Dr Doyle and Mr Richards will not stand for re-election at Bradken's Annual General Meeting ("AGM").
