ASX: NXT - TRADING HALT REQUEST

NEXTDC Limited (ACN 143 582 521) (NEXTDC) requests a trading halt for its ordinary shares (ASX: NXT) under Listing Rule 17.1 prior to the commencement of trading today.

NEXTDC provides the following information for the purposes of Listing Rule 17.1:

- NEXTDC requests the trading halt to enable it to undertake completion of the institutional (a) component of the proposed capital raising that will also be announced today.
- (b) NEXTDC requests the trading halt continue until the earlier of:
 - NEXTDC releasing an announcement in relation to the completion of the (1) institutional component of the capital raising; or
 - the open of trading on Wednesday, 25 November 2015. (2)
- NEXTDC expects the trading halt will end by the close of trading on Monday, 23 November (c) 2015.
- (d) NEXTDC is not aware of any reason why the trading halt should not be granted.
