To be eligible, you will need to have purchased your units prior to the Ex Distribution Date, for the transaction to have been settled and for your unitholding to have been entered on the register as of the Record Date.

The Distribution Reinvestment Plan (“DRP”) is operating for the Fund. Any DRP elections must be received by the registrar, Link Market Services, by 4 December 2015.
