- the issue of 11,656,498 New Shares at an issue price of NZ\$2.80 per New Share; and
- the sale and transfer of 1,071,428 existing Shares at a sale price of NZ\$2.80 per Share.

The total number of Shares on issue upon completion of the Offer is 96,834,838.

Confirmation of cleared funds

AFT confirms that it has received cleared funds for the complete amount of the issue price of every Share issued to every successful applicant for Shares under the PDS.

Confirmation of Conversion of Preferred Shares and Share Split

AFT confirms completion of:

- the conversion on a 1-for-1 basis of AFT's 140,000 Series A Preferred Shares and 54,120 Series B Preferred Shares; and
- the subsequent 62:1 Share Split.

Waiver of NZX Listing Rules

NZX Limited ("NZX") has granted AFT a waiver from NZX Main Board Listing Rule 5.2.3 in respect of its ordinary shares quoted on the NZX Main Board ("Shares") for a period of 12 months to the extent the rule requires AFT to have at least 25% of Shares held by "Members of the Public" holding at least a "Minimum Holding" (as that term is defined in the NZX Main Board Listing Rules).
