ISSUE OF SHARES

Aeris Environmental Ltd (ASX:AEI) advises that, at the Company's Annual General Meeting (AGM) held on 30 November 2015 shareholders approved the conversion of loans from its three Directors into shares so that Messrs Maurie Stang, Bernard Stang and Steven Kritzler will each receive 1,000,000 shares by way of settlement of amounts owing to them relating to loans they made to the Company of a total of A\$1,500,000, at a deemed price of A\$0.50 per share, being the same price as the last placement, which was completed on 18 June 2015. The current share price is A\$0.45; the share price at the date of the Notice of AGM was A\$0.36, and this compared to a share price high of A\$0.435 and a low of A\$0.34 in the month leading up to the Notice of AGM. The shares rank equally in all respects with the existing fully paid ordinary shares in the Company. The Company now advises that it has issued these 3,000,000 fully paid ordinary shares.
