Investa Office Fund (IOF) - Form 605: Ceasing to be a substantial holder

Enclosed is a notice of ceasing to be a substantial holder by Investa Office Management Holdings Pty Limited (IOMH) and its subsidiaries.

On 1 March 2016, IOMH sold 54,878,455 stapled securities of IOF to Post Sale Portfolio Issuer Pty Limited (PSP). At the time of the sale, IOMH was a related body corporate of PSP due to both IOMH and PSP being related bodies corporate of Morgan Stanley. As a result, the sale did not result in a change to the voting power of either PSP or IOMH.

On 4 March 2016, IOMH and its subsidiaries ceased to be related bodies corporate of Morgan Stanley. As a result, IOMH and its subsidiaries no longer have any voting power in IOF units.
