### **Estimated Pre-Tax NTA per share – 15 March 2016**

In the interests of keeping the market fully informed during the final weeks before the Company's outstanding options expire, the Board of the Global Value Fund (GVF) has asked the manager to produce a daily estimate of the Company's pre-tax NTA per share for release to the market.

This estimate includes the month-to-date change in the Company's investment portfolio, adjusted for the allotment of newly issued shares and Company operating costs. The Company is allotting new shares issued through the exercise of its outstanding options on a daily basis until their expiry on 17 March 2016.

The manager estimates that the pre-tax NTA per share for the Company, using closing market prices and the current number of shares outstanding on 15 March 2016, was \$1.0964.

The manager has made reasonable efforts to produce this estimate of the Company's pre-tax NTA per share, but takes no responsibility for its accuracy.
