ISSUE OF SECOND CONVERTIBLE NOTE TO ARENA

Genex Power Limited (**ASX: GNX, Genex** or the **Company**) is pleased to advise that it has now received the second instalment of almost \$538,000 from the Australian Renewable Energy Agency (**ARENA**) in respect of the federal government funding approved by ARENA as announced to the market on 18 December 2015.

The receipt of this second instalment from ARENA, along with the first instalment of more than \$730,00 received two weeks ago, will be applied towards the development of the Company's Feasibility Study for its Pumped Storage Hydro Project at Kidston.

Under the terms of the Funding Agreement with ARENA, Genex has issued a second Convertible Note for which an Appendix 3B is attached.
