The new Ordinary Shares will rank equally in all respects with the existing ordinary shares of the Company. Application for admission to trading on AIM ("Admission") for 748,510 new Ordinary Shares has been made and Admission is expected to be effective from 17 March 2016.

Following Admission, the total issued share capital of the Company will be 200,923,009 ordinary shares. The Company holds no Ordinary Shares in treasury.
