ISSUE OF THIRD CONVERTIBLE NOTE TO ARENA

Genex Power Limited (**ASX: GNX, Genex** or the **Company**) is pleased to advise that it has now received the third instalment of just over \$386,000 from the Australian Renewable Energy Agency (**ARENA**) in respect of the federal government funding approved by ARENA as announced to the market on 18 December 2015.

The receipt of this third instalment from ARENA brings the total instalments received to almost \$1,600,000. The funds will continue to be applied towards the development of the Company's Feasibility Study for its Pumped Storage Hydro Project at Kidston.

Under the terms of the Funding Agreement with ARENA, Genex has issued a third Convertible Note for which an Appendix 3B is attached.
