Notice is hereby given that an Annual General Meeting of Shareholders of Emperor Range Group Limited (**Company**) will be held at Level 9, 420 King William Street, Adelaide, SA 5000 on Monday 23 May 2016 at 2:00 pm (ACST)(**Meeting**).

The Directors have determined pursuant to regulation 7.11.37 of the *Corporations Regulations 2001* (Cth) that persons eligible to vote at the Meeting are those who are registered as Shareholders on 19 May 2016 at 7 pm (ACST).

**1. Explanatory Memorandum**

Further details of the Resolutions in this Notice of Meeting are contained in the Explanatory Memorandum accompanying this Notice of Meeting. The Explanatory Memorandum should be read together with, and forms part of, this Notice of Meeting.

**2. Voting Exclusion Statement**

**Resolution 1**

A vote on Resolution 1 must not be cast (in any capacity) by or on behalf of any of the following persons:

- a) a member of the Key Management Personnel details of whose remuneration are included in the Remuneration Report; or
- b) a Closely Related Party of such a member.

However, a person described above may cast a vote on Resolution 1 as a proxy if the vote is not cast on behalf of a person described above and either:

- a) the person is appointed as a proxy by writing that specifies the way the proxy is to vote on the resolution; or
- b) the person is the chair of the meeting and the appointment of the chair as proxy:
  - i) does not specify the way the proxy is to vote on the resolution; and
  - ii) expressly authorises the chair to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel for the Company or, if the Company is part of a consolidated entity, for the entity.

**3. Proxies**

Shareholders unable to attend the Meeting can complete the Proxy Form contained in this Notice of Meeting. The form must be received by the Company at the address or the facsimile number indicated on the Proxy Form no later than Saturday 21 May 2016 at 2:00 pm (ACST).

In accordance with the Corporations Act, a person's entitlement to vote at the Annual General Meeting will be determined by reference to the number of fully paid ordinary shares registered in the name of that person (reflected in the register of members) as at Saturday 21 May 2016 at 2:00 pm (ACST). Members that do not hold shares at this time will be ineligible to vote at the meeting.

Shareholders unable to attend the Meeting are urged to complete the attached Proxy Form and return it to the Company in accordance with Note 2. A member entitled to attend and vote at the meeting is entitled to appoint a proxy. A proxy need not be a member of the Company. A shareholder who is entitled to cast two or more votes may appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise. If no proportion or number is specified, then in accordance with section 249X(3) of the Corporations Act 2001, each proxy may exercise half of the votes. Proxies must be lodged at the registered office of the Company or the Company's share registry, no later than forty-eight hours before the meeting or adjourned meeting. A proxy form together with a return addressed envelope is provided with this notice.

Members will be provided with a reasonable opportunity to ask questions about or make comments on the management of the Company including the opportunity to ask questions of the Company's auditor. Members are invited to submit any questions to the Company no later than 5 business days before the meeting.

#### **4. Voting In Person**

Shareholders who plan to attend the Meeting are asked to arrive at the venue 30 minutes prior to the time designated for the Meeting, if possible, so that we may check the shareholding against the Share Register and note attendances.

In order to vote in person at the Meeting, a corporation that is a shareholder or a proxy may appoint an individual to act as its representative. The appointment must comply with the requirements of Section 250D of the Corporations Act. The representative should bring to the Meeting evidence of their appointment, including any authority under which it is signed.

## SECTION 2 - EXPLANATORY MEMORANDUM

### Introduction

This Explanatory Memorandum has been prepared for the information of shareholders in connection with the business to be conducted at a meeting of the Company to be held at Level 9, 420 King William Street, Adelaide, SA 5000 on 23 May 2016 at 2:00 pm (ACST).

This Explanatory Memorandum should be read in conjunction with, and forms part of, the accompanying Notice of Meeting. The purpose of this Explanatory Memorandum is to provide information to Shareholders in deciding whether or not to pass the Resolutions set out in the Notice.

A Proxy Form is located at the end of the Explanatory Memorandum.

### Action to be taken by Shareholders

Shareholders should read the Notice and this Explanatory Memorandum carefully before deciding how to vote on the Resolutions.

#### 1) Proxies

A Proxy Form is attached to the Notice. This is to be used by Shareholders if they wish to appoint a representative (a 'proxy') to vote in their place. All Shareholders are invited and encouraged to attend the Meeting or, if they are unable to attend in person, sign and return the Proxy Form to the Company in accordance with the instructions thereon. Lodgement of a Proxy Form will not preclude a Shareholder from attending and voting at the Meeting in person.

Please note that:

- a) A member of the Company entitled to attend and vote at the Annual General Meeting is entitled to appoint a proxy;
- b) A proxy need not be a member of the Company; and
- c) A member of the Company entitled to cast two or more votes may appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise, but where the proportion or number is not specified, each proxy may exercise half of the votes.

The 2015 Annual Report has also been sent by post to those shareholders who have previously elected to receive a hard copy.</p> <p>Section 250R(2) of the Corporations Act requires that a resolution to adopt the Remuneration Report be put to the vote of the Company. Shareholders should note that the vote on Resolution 1 is advisory only and, subject to the matters outlined below, will not bind the Company or the Directors. However, the Board will take the outcome of the vote into consideration when reviewing</p>

Accordingly, Mr Chen Yuhan as a Director of the Company and, being eligible, offers himself for re-election.</p>

	<p>A resume for Mr Chen follows:</p> <p><b>Chen Yuhan</b> (Executive Chairman and Managing Director)  Chen Yuhan (LLB) obtained a law degree from the economic Law Department of East China University of Politics and Law. After graduation, he served in the Fuzhou Foreign Economic and Trade Commission and engaged in the foreign investment approval process. He commenced in private practice in 1996, and during practice specialized in corporate legal commerce. In 2010, he established the Fujian Helun Law Firm and served as Director, and in the same year established the Beijing Jinwo (Beijing) Venture Capital Co., Ltd branching into the commercial areas of private equity (PE) investment and capital operation. Mr Chen was appointed by the Fuzhou Arbitration Commission as an arbitrator for two consecutive terms from February 23, 2010 to date.</p> <p>This resolution is an ordinary resolution.</p> <p><b>The Directors of the Company (with Mr Chen abstaining) unanimously recommend to all Members that they vote in favour of this Resolution.</b></p> <p>The chair intends to vote undirected proxies in favour of this resolution.</p>

### TO VOTE BY COMPLETING THE PROXY FORM

#### STEP 1 APPOINTMENT OF PROXY

Indicate who you want to appoint as your Proxy.

If you wish to appoint the Chair of the Meeting as your proxy, mark the box. If you wish to appoint someone other than the Chair of the Meeting as your proxy please write the full name of that individual or body corporate. If you leave this section blank, or your named proxy does not attend the meeting, the Chair of the Meeting will be your proxy. A proxy need not be a security holder of the company. Do not write the name of the issuer company or the registered securityholder in the space.

#### Appointment of a Second Proxy

You are entitled to appoint up to two proxies to attend the meeting and vote. If you wish to appoint a second proxy, an additional Proxy Form may be obtained by contacting the company's securities registry or you may copy this form.

To appoint a second proxy you must:

- (a) complete two Proxy Forms. On each Proxy Form state the percentage of your voting rights or the number of securities applicable to that form. If the appointments do not specify the percentage or number of votes that each proxy may exercise, each proxy may exercise half your votes. Fractions of votes will be disregarded.
- (b) return both forms together in the same envelope.

#### STEP 2 VOTING DIRECTIONS TO YOUR PROXY

To direct your proxy how to vote, mark one of the boxes opposite each item of business. All your securities will be voted in accordance with such a direction unless you indicate only a portion of securities are to be voted on any item by inserting the percentage or number that you wish to vote in the appropriate box or boxes. If you do not mark any of the boxes on a given item, your proxy may vote as he or she chooses. If you mark more than one box on an item for all your securities your vote on that item will be invalid.

#### Proxy which is a Body Corporate
