ISSUE OF GOLDPHYRE RESOURCES LIMITED SECURITIES – SECONDARY TRADING NOTICE NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("ACT")

On 22 April 2016, Goldphyre Resources Limited ("**Company**") issued 1,687,500 fully paid ordinary shares in the capital of the Company at an issue price of \$0.064 per share, as approved by shareholders of the Company. A further 29,030,772 fully paid ordinary shares, as approved by shareholders of the Company, and 6,860,000 unlisted options were issued as consideration for the acquisition of Potash Rights on two exploration licenses adjacent to the Company's Lake Wells Potash Project ("**Securities**").

Secondary Trading Exemption

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.
