TOPBETTA CONTINUES STRONG GROWTH THROUGHOUT APRIL

The Board of TopBetta Holdings Limited (ASX:TBH) ("TopBetta" or the "Company") is pleased to provide shareholders with an update on the Company's activities during April.

Highlights:

- Quarterly active users¹ increased by 24%
- Revenues for the 3 months ending 30 April up by 21% on March quarter
- A \$250,000 tournament was held over The Championship weekend
- Over 500 individual tournaments were held during the month of April

During the month the Company's quarterly active users increased from **4,247** as at **31 March 2016** to **5,271** as at **30 April 2016**.

With the increase in active users, the Company has seen unaudited turnover and revenues increased through April as shown in the table below, with quarterly turnover surpassing \$1,000,000 /quarter²:

With The Championship weekend and the additional 500 tournaments run during the month, the Company's tournaments platform is continuing to provide a successful complementary product to TopBetta's traditional bookmaking model.
