(g) Reason for issue	Employees cancelling options issued under the 2011, 2012 and 2013 issue of the Fisher & Paykel Healthcare 2003 Share Option Plan. 61,687 options were cancelled on 13 September 2016 pursuant to the Cancellation Offer approved by shareholders at the ASM held on 12 August 2004. 42,775 shares were issued in consideration of the cancellation of the options and are equal in value to the gain on the options (such gain being calculated based on exercise prices of \$2.29, \$2.36, \$2.43, \$2.06 and \$3.57). 4,666 shares were issued to an employee exercising options issued under the 2011 issue of the Fisher & Paykel Healthcare 2003 Share Option Plan based on an exercise price of \$2.43. Employees exercising PSRs issued under the 2013 issue of the Fisher & Paykel Healthcare Performance Share Rights Plan. 26,230 PSRs were exercised on 13 September 2016 and 26,230 shares were issued.
