

**NOTICE GIVEN UNDER SECTION 708A(5) OF THE CORPORATIONS ACT**

This notice is given by King River Copper Limited ("Company") under section 708A(5)(e) of the Corporations Act in relation to an issue of 127,133,897 fully paid ordinary shares ("Shares") by the Company without disclosure to investors under Part 6D.2 of the Corporations Act, under the Company's Share Purchase Plan announced to ASX on 14 July 2016.
