Dear Shareholder

Western Mining Network Limited - pro-rata renounceable entitlement issue

As announced on 8 July 2016, Western Mining Network Limited (**WMN**) is undertaking an 8 for 1 pro rata renounceable entitlement issue (**Entitlement Issue** or **Offer**) of approximately 2,182,516,136 fully paid ordinary shares (**New Shares**) to raise approximately \$2,182,516. The price of New Shares under the Offer is \$0.001 each (**Issue Price**).

The Company lodged a prospectus for the Offer (**Prospectus**) with ASIC and ASX on 14 July 2016.

The Offer is being made to all shareholders of the Company (**Shareholders**) named on its register of members at 5:00pm WST on 20 July 2016, whose registered address is in Australia, New Zealand or Indonesia.

New Shares will rank equally with all fully paid ordinary shares in the capital of the Company (**Shares**) already on issue.

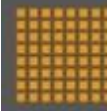
Following completion of the Offer, the Company will have issued approximately 2,182,516,136 New Shares resulting in total Shares on issue of approximately 2,455,330,653.

Ineligible shareholders

A Shareholder who has a registered address outside Australia, New Zealand or Indonesia (**Ineligible Shareholder**) will not be eligible to participate in the Offer.

You are not eligible to participate in the Offer and you will not be sent a copy of the Prospectus. This decision has been made pursuant to Listing Rule 7.7.1(a) of the ASX Listing Rules after taking into consideration the costs of complying with legal and regulatory requirements in jurisdictions outside of Australia, New Zealand and Indonesia compared with the small number of Ineligible Shareholders and the number and value of New Shares to which they would otherwise be entitled.

The Company has appointed LeMessurier Securities Pty Ltd (**Nominee**) as nominee to sell the rights to subscribe for New Shares pursuant to the Prospectus (**Entitlements**) to which

Ineligible Shareholders are entitled. The Nominee will have the absolute and sole discretion to determine the timing and price at which the Entitlements may be sold and the manner of any such sale.

Any interest earned on the proceeds of the sale of these Entitlements will firstly be applied against expenses of such sale, including brokerage, and any balance will accrue to Ineligible Shareholders.

The net proceeds of the sale of these Entitlements will then be forwarded by the Company as soon as practicable to the Ineligible Shareholders, in proportion to their share of such Entitlements (after deducting brokerage commission and other expenses). If any such net proceeds of sale are less than the reasonable costs that would be incurred by the Company for distributing those proceeds, such proceeds may be retained by the Company.

Notwithstanding that the Nominee may sell Entitlements, Ineligible Shareholders may nevertheless receive no net proceeds if the costs of the sale are greater than the sale proceeds.

There is no guarantee that the Nominee will be able to sell Entitlements of Ineligible Shareholders on ASX and Ineligible Shareholders may receive no value for the Entitlements. Both the Company and the Nominee take no responsibility for the outcome of the sale of such Entitlements or the failure to sell such Entitlements.
