## **Appendix 3B: Issue of shares to DotProperty vendors**

Mitula Group Limited ("**Mitula**" or the "**Company**") (ASX:**MUA**) advises that a total of 4,349,213 new fully paid ordinary shares (**Consideration Shares**) have been issued as detailed in the accompanying Appendix 3B.

On 5 September 2016, the Company announced the acquisition of 100% of the issued share capital of DotProperty Pte Ltd. The Consideration Shares form part of the consideration payable in connection with the acquisition of Dot Property Pte Ltd.

A total of 827,987 Consideration Shares are subject to voluntary escrow arrangements for a period of 6 months from the date of issue. The balance of the Consideration Shares will be subject to a voluntary escrow period of 12 months.
