Telstra launches Sóshir via Telstra Apps Marketplace

The Company announced in April 2016 that Manalto, via its 100% owned subsidiary Sóshlr Pty Ltd, signed an agreement for Telstra to sell Sóshlr via Telstra Apps Marketplace.

Sóshlr offers a range of base packages and upsell paths. MSRP range between USD\$36 and USD\$3000 per customer per annum and final pricing is at partner discretion. Manalto has plans to roll out new premium add-on features for its Sóshlr product that will add to the base license fees.
