ISSUE OF MANHATTAN CORPORATION LIMITED SHARES Notice Pursuant to section 708A(5)(e) of the *Corporations Act 2001*

Manhattan Corporation Limited ("Manhattan" or "the Company") advises that it has today completed the issue of 6,900,000 fully paid ordinary shares in Manhattan ("Shares") to sophisticated and institutional investors.

In accordance with the requirements of section 708A(6) of the *Corporations Act 2001* ("Act"), Manhattan notifies ASX that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Act;
