JUNE 2016 QUARTERLY ACTIVITIES REPORT

HIGHLIGHTS

With the increasing zinc price, there is increasing interest in the Company's Yukon Base Metal Project that hosts resources of:

12.6Mt at 5.3% zinc and 0.9% lead

- Continued to assess alternatives to advance the Yukon Base Metal Project
- Advanced discussions regarding multiple new business opportunities

During the June 2016 quarter Overland Resources Limited (ASX: OVR; "Overland" and the "Company") continued to assess alternative ways to advance and realise value from the Yukon Base Metal Project, where Measured, Indicated and Inferred Resources currently total 12.6 Mt at 5.3% zinc and 0.9% lead (see Table 1). With the global zinc price steadily increasing, and a positive outlook for this trend to continue, there is increasing interest in this asset.

The Company has also continued to evaluate numerous other business opportunities that provide potential alternatives to more rapidly realise significant returns for shareholders. The Company is advancing discussions regarding several opportunities.

Following Mr David Oestreich's resignation as a non-executive director, Mr Scott Robertson was appointed a non-executive director of the Company.

The Company remains well-funded, with approximately \$660,000 cash at bank at 30 June 2016.
