Annual General Meeting Results

The following results of the Annual General Meeting of Australian Leisure and Entertainment Property Management Limited and a meeting of the unitholders of Australian Leisure and Entertainment Property Trust held on 25 October 2016 are provided in accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001.

Shareholders voted overwhelmingly in favour of all resolutions put to the meeting.

Resolution 1	That James McNally, Executive Director, be elected as a Director of the Company was passed.
Resolution 2	That the Remuneration Report for the financial year ended 30 June 2016 be adopted was passed.
Resolution 3	That the Executive Incentive Scheme grant of rights to the Managing Director be approved was passed.

The Board was particularly encouraged that investors, holding approximately 68% of all securities on issue, voted on this year's resolutions. The number of investors voting more than doubled to around 750.
