SRG AWARDED CONTRACT FOR CONSTRUCTION OF SILOS AT HANSON OPERATED QUARRY

Highlights

- SRG awarded \$8.4m sub-contract under Brolton Group for the design development and construction of concrete silos & associated concrete structures at Hanson operated Bass Point Quarry near Wollongong
- Potential for scope increase through pre agreed variation rates on the quarry project development

SRG Limited (**ASX:SRG**) ("SRG"), a leading complex services company, is pleased to announce that it has been awarded a sub-contract under The Brolton Group ("Brolton") valued at \$8.4m for the design development and construction of concrete silos & associated concrete structures at Bass Point Quarry near Wollongong south of Sydney operated by Hanson.

SRG will act as a sub-contractor to Brolton in fulfilling the requirements of delivering six slip-form concrete silos each measuring 15 metres in diameter and 15.7 metres in height. Also included within the contract is 2053m² post tensioned slab (which the silos are erected upon), silo recovery culvert, scalps stockpile tunnel, primary stockpile reclaim tunnel and a primary crusher station.

The works are to begin in July and are expected to be completed by February 2017. On completion, the silos will be used for containment of guarry aggregates and sand.

SRG Managing Director, David Macgeorge said, "We are pleased to have been selected as sub-contractor under Brolton for our expertise to design and construct the silos for Hanson's operations. SRG has a long history of successfully delivering slipform construction projects from iconic telecommunications towers to power station cooling towers."
