ALLOTMENT OF SHARE PURCHASE PLAN SHARES

On Friday 19th August 2016, the Company announced that the recent Share Purchase Plan had raised \$2,451,500 and was supported by 249 shareholders.

The Company has today allotted 128,973,685 new shares with respect to the SPP and attached is an Appendix 3B for this allotment and issue of shares.

The Company announced on 11th August 2016 that it has recommenced a Pre-Feasibility study focusing on the oxide, supergene and transition mineralization within the Company's Resource at Aphrodite. The drilling is now well under way and very importantly with excellent core recovery to date which means there will be reliable samples on which assays and geotechnical testing and metallurgical testing can be carried out.

In addition the current program of drilling includes several exploration drill holes to test the strike and depth extent of previous drilling at Phi North, some 300m north of the currently designed open pit and the Company's JORC compliant resource.

Further announcements providing updates on all this Pre-Feasibility work will be provided to shareholders and the ASX over the next 3 months.
