# Zinc Project Awarded \$114,500 Drilling Grant

- Razorback West zinc project to get government backing in form of drilling grant
- > Drilling to start as soon as Funding Deed is signed
- > Optimistic for September start-up
- Razorback West has potential to host significant Broken Hill-type (BHT) mineralisation

Silver City Minerals Limited (ASX: SCI) ("Silver City" or "the Company") is pleased to announce that the New South Wales government has awarded the Company \$114,500 as part of the current Co-operative Drilling Program (Round 2). The monies are specifically designed to assist in a three hole diamond drilling program (approximately 1000 metres in total) to test targets at the Razorback West zinc project 15 kilometres northeast of Broken Hill.

#### The Project

Silver City considers Razorback West to be the northern, fault-offset continuation of the Broken Hill mine corridor. As such, it has potential to host a significant Broken Hill-type (BHT) orebody.

The project is largely overlain by a veneer of shallow soil and alluvial cover, and for this reason appears not to have attracted significant attention from previous explorers. It was not until Silver City acquired the tenure that it became apparent that the rocks within the exploration licence represent a considerable exploration opportunity.

SCI has conducted detailed rotary airblast (RAB) geochemical programs, a variety of geophysical surveys and preliminary drilling. This work shows that not only are the rocks part of the important ore-hosting Broken Hill Group, they are also enriched in zinc, lead and manganese; three important elements in the famous Broken Hill deposit and mine corridor.




Figure 1 Location or the Razorback West zinc project in relation to the Broken Hill Zinc-Lead- Silver Deposit

Early RC drilling returned broad intersections of low grade lead and zinc. The anomalous and prospective rock sequence extends for at least 5 kilometres in a north-east direction and is 200 to 400 metres wide (Figure 1).

The three drill holes designed as part of the upcoming program will extend to depths of 300 to 400 metres. They will test two coincident geochemical and electromagnetic targets and an excellent geological target.

#### Comment

Bob Besley, the Chairman of Silver City Minerals commented: "It has always surprised me that despite its close proximity to the world's largest and richest zinc-lead-silver deposit, the Razorback area has had little exploration attention. Prior to Silver City becoming involved there had never been a drill hole in the entire Razorback corridor, a testimony to the paucity of exploration here and elsewhere in the district.

The government grant is an excellent endorsement of the technical ability and tenacity of the Silver City team and its Broken Hill-based geological consultants."
