### Notice under Section 708A

Iron Mountain Mining Limited (**Company**) hereby notifies the Australian Stock Exchange in accordance with Section 708A (5)(e) of the Corporations Act 2001 (**the Act**) that:

The Company issued 20,000,000 fully paid ordinary shares on 27 September 2016 in part consideration for the acquisition of 50% of the share capital in AU Capital Mining Pty Ltd.

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under Section 708 or 708A of the Act. By giving this notice, sale of the shares will fall within the exemption in Section 708A(5) of the Act.
