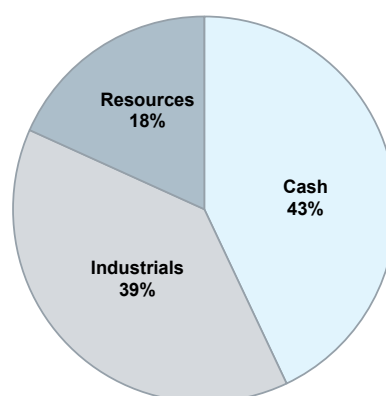

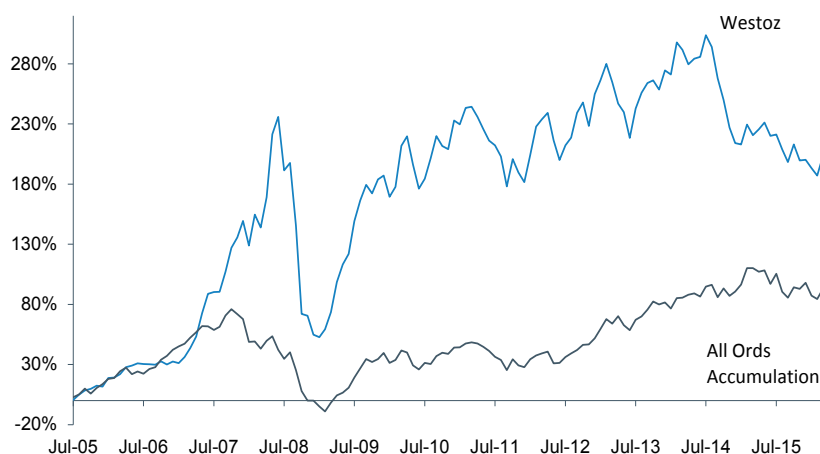
- Market recovers with a 4.7% rise in March. The gold sector was the only major area of weakness, falling 4.5%
