#### **About Story-i**

Singapore incorporated Story-i Pte Ltd operates 20 stores in Indonesia through its 95% owned subsidiary PT Inetindo Infocom. The Indonesian retail operations consist of 13 Story-i stores, which are Apple Authorised Resellers, with instore GeekZone outlets providing software, equipment servicing and apps, and 6 iConnect stores retailing Samsung and Lenovo products and accessories. There is also a flagship Apple Premium Reseller store in Ho Chi Minh City.
