Update on capital raising, acquisitions and reinstatement to official quotation

Capital raising

TasFoods Limited (**Company**) is pleased to announce that it has completed its recent capital raising under the prospectus issued on 25 May 2016. The Company accepted applications for 101,577,000 ordinary shares at an issue price of \$0.25 each and raised \$25,394,250 (before costs). Those shares were issued today.

Acquisitions

The Company has today completed the acquisition of Nichols Poultry Pty Ltd and associated assets as well as Shima Wasabi Pty Ltd.

As part of the consideration provided by the Company for those acquisitions, the Company has today issued 8,000,000 ordinary shares to the vendor of Nichols Poultry Pty Ltd (Nichols Investments Pty Ltd as trustee for the R & J N Family Trust) and 600,000 ordinary shares to each of the vendors of Shima Wasabi Pty Ltd (Stephen Welsh and Karen Welsh). All of these shares were issued at a notional issue price of \$0.25 each and no funds were raised by the Company from the issues.

The shares issued to the vendor of Nichols Poultry Pty Ltd are subject to a voluntary escrow deed which restricts the holder from dealing with any of those shares, such as disposing of them or creating security interests in them, until 15 December 2016.

Reinstatement to official quotation

The Company has received notification from ASX that it has decided to reinstate the Company's securities to official quotation on ASX on a date to be decided by ASX, subject to the Company complying with certain conditions. The Company is working to satisfy those conditions so that reinstatement can occur next Monday 20 June 2016 (subject to ASX's approval).
