Letter Deed - Voting rights

Background

Ebert Investments Pty Ltd ACN 138 124 044 (**Ebert Investments**) is the registered holder of 5,757,494 Unity Pacific Group (**UPG**) stapled securities (**Prescribed Securities**). Ebert Investments therefore has a Relevant Interest (as defined in the *Corporations Act 2001* (Cth) (**Act**)) in the Prescribed Securities under section 608(1) of the Act.

Warren James Ebert (Warren Ebert) holds 100% of the shares in and controls Ebert Investments. Warren Ebert therefore has a Relevant Interest in the Prescribed Securities under section 608(3) of the Act.

Ebert Investments, Warren Ebert, Sentinel Security Investments Limited ACN 614 308 735 (Sentinel) and Gladius Holdings Pty Ltd ACN 169 446 146 (Gladius) and Stacey Nicole Ebert (Stacey Ebert) are Associates (as defined in the Act) of each other in relation to UPG.

Ebert Investments and Warren Ebert wish to confer upon Sentinel the power to exercise, or control the exercise of, the right to vote attached to the Prescribed Securities. The purpose of this letter deed is to record the parties agreement in relation to the conferral of the voting rights by Ebert Investments and Warren Ebert on the terms set out below:

- 1. With effect immediately upon this deed being executed by all parties, Ebert Investments and Warren Ebert agrees that:
 - Sentinel may control the exercise of the right to vote attached to the Prescribed Securities (Voting Rights);
 - Sentinel may direct Ebert Investments as to how to exercise the right to vote attached to the Prescribed Securities (Direction);
 - c. Ebert Investments must comply with the Direction;
 - d. Warren Ebert must procure that Ebert Investments complies with the Direction;
 - e. Ebert Investments appoints Sentinel as its attorney to execute any document to give effect to the above.
- Sentinel may relinquish the rights and powers conferred in clause (1) by notice in writing to Ebert Investments.
- Upon execution of this Letter Deed where provided below, the parties acknowledge and agree that this Letter Deed will be binding and enforceable.
