SHAREHOLDERS APPROVE SCHEME OF ARRANGEMENT

Unity Mining Limited (UML or "Unity") advises that shareholders today voted in favour of approving the Modified Scheme Resolution in relation to the Scheme of Arrangement which, subject to Court approval, will result in UML becoming controlled by Diversified Minerals Pty Ltd.

Following approval of the Preliminary Resolution by the requisite majorities, the Modified Scheme Resolution was passed by the requisite majorities of UML shareholders with:

- 80.15% of UML shareholders who voted, voting in favour of the resolution; and
- 91.43% of votes cast in favour of the resolution.

Detailed information of the results in relation to the meeting is set out on the following pages.

The Second Court Hearing to approve the Scheme is scheduled for 26 May 2016 at the Supreme Court of Victoria. If the Court grants an order approving the Scheme, trading in Unity shares on the ASX is expected to cease at the close of business on that day.

Shareholders who hold shares on the Record Date for determining entitlements to receive the total cash payments (expected to be 7:00pm on 31 May 2016) will receive 3.3 cents cash for each Unity share they own, comprising 2.3 cents by way of Scheme consideration and 1.0 cent by way of capital return.

The Implementation Date for the Scheme is expected to be 1 June 2016 and the total cash payments are expected to be dispatched to shareholders on 2 June 2016.
