Completion of Placement

Acacia Coal Limited (the Company) has completed the Placement to sophisticated and professional investors as announced on 17 October 2016 to raise \$406,704 before costs through the issue of 135,568,188 ordinary shares (Shares) at \$0.003 each.

The Company will issue the 135,568,188 Shares today as set out in the Appendix 3B. The funds raised will be used for costs associated with the acquisition of Riversdale Anthracite Colliery (RAC) and planned expenditure on the RAC, together with planned expenditure on Acacia's Comet Ridge Coal Project and working capital.

The Appendix 3B is attached for the issue.
