Jervois Project Update

- DHEM survey at Rockface identifies new conductor
- Metallurgical testwork on Rockface mineralisation confirms good recovery and concentrate grade




Figure 1 Rockface DHEM Conductors (view angle 158 deg)




Figure 2 Rockface DHEM plates (view angle 254 deg)

A Down Hole Electromagnetic Survey (DHEM) of diamond hole KJCD197 has been completed and results from this survey have now been modelled (Figures 1 & 2).

The key outcomes of the modelling of this data are

- 1. New anomaly, Conductor 6 observed in the hanging wall of Conductor 3. It appears to be in in the same mineralised horizon as Conductors 1 & 2 and is centred to the east of KJCD197
- 2. Conductor 3 continues to extend and broaden down dip of KJCD197
- 3. Modelled response from Conductor 5 remains similar to previous modelling and extends for 130m below the intercept with KJCD197

Conductors 1, 2, 4 and 6 remain to be tested by drilling.

Drilling at Rockface will continue to be guided by the DHEM that is proving to be very effective at identifying zones of higher grade mineralisation proximal to each drill hole. The success of DHEM at Jervois is due in part to the highly resistive host rocks that contrast well with the conductive sulphide mineralisation that is dominated by chalcopyrite. No other conductive sources such as graphitic units or pyrite dominant bodies of mineralisation have been intersected at Rockface.

Metallurgical Samples Tested

Samples of quarter core from three drill holes (KJCD171 252-270m, KJCD182 283-304m and KJCD183 360-380m) were supplied for testing.

Selected intervals were combined from each drill hole and these were then sub-sampled and combined to form the Rockface 171,182,183 Composite. The head analysis for the Rockface Composite is shown in Table I below:

Results Discussion - Flotation

The testwork study performed on the Rockface composite sample, which was prepared from the three core samples supplied showed that:

- The sample responded well to the flowsheet and reagent scheme developed as part of the prefeasibility study.
- The grade and recovery for copper were slightly better than expectations for the composite head grade i.e. 2.05% Cu Head grade providing >95% recovery at 25% Cu concentrate grade. The following plot relates the Rockface testwork to the previous testwork database.




Figure 3 Copper Feed Grade vs. Copper Recovery - Sulphide Ores

• These results were achieved at the 120μm P₈₀ grind size used in previous work and for the basis of the prefeasibility study.




Figure 4 Plan of Rockface drilling
