GOLD DRILLING PROGRESSES AT EAST LAVERTON

HIGHLIGHTS:

- Initial programme at Bristol has been completed with 1,580m of RC (reverse circulation) drilling
- Drilling expanded at Bristol to test for anomalous supergene gold and bedrock geology over the Bristol magnetic sequence
- Follow-up RC drilling at Ascalon has commenced
- 2,000m of new drilling planned at Ascalon to further test the extensive metal-rich hydrothermal system identified by initial drilling earlier this year
- Assay results pending

GOLD DRILLING CONTINUES AT EAST LAVERTON PROJECT

St George Mining Limited (ASX: **SGQ**) ('St George Mining' or 'the Company') is pleased to provide an update on the drill programme for its priority gold targets at the 100% owned East Laverton Project in Western Australia.

Seventeen drill holes have been completed at the Bristol gold target for 1,580m of RC (reverse circulation) drilling. Details of the drill holes are shown in Table 1.

Six drill holes at Bristol – BRRC003 to BRRC008 - were drilled to test the bedrock and regolith geology along a gold anomaly that extends for over 1km. The gold anomaly is within a broad supergene horizon – typically at around 40m depth. A further eleven short drill holes – BRRC009 to BRRC019 - were completed across the prominent magnetic anomaly at Bristol to test for supergene gold mineralisation and to determine the bedrock geology. Deeper drilling in this area will be considered subject to assay results.

At the Ascalon gold target, drilling is underway in the follow-up programme of ten RC drill holes for 2,000m of drilling. The initial reconnaissance drilling by St George at Ascalon identified a prospective hydrothermal gold system that could potentially extend over 2,000m.

The follow-up drilling at Ascalon will test for gold mineralisation along strike to the north-west and southeast of the favourable alteration zones identified by initial drilling.

John Prineas, Executive Chairman of St George Mining, said:

"The priority gold targets at East Laverton satisfy key targeting criteria for significant gold deposits – including important early fundamental structures that are first order controls on gold mineralisation.

"Our drill programmes represent the first ever systematic exploration for gold at these targets and provide an opportunity for an exploration breakthrough in this highly prospective yet under-explored area."



SYSTEMATIC EXPLORATION AT THE PRIORITY GOLD TARGETS

The gold anomaly at Bristol was identified by shallow drilling completed in the 1990's which intersected widespread anomalous gold (>0.5g/t) along the contact of the Bristol ultramafics/mafics with granites – a favourable setting for gold mineralisation.

The six deep RC drill holes completed by St George at Bristol have intersected sheared mafic and ultramafic rocks with some later felsic intrusives. The mafic rocks are schistose with chlorite-carbonate alteration and some quartz veining. Assay results for these six holes are due shortly.




Figure 1 – the Bristol gold target (against RTP magnetics) with St George's completed drill holes shown.

An additional eleven shallow RC drill holes were completed at Bristol to provide a cross-section over the prominent magnetic anomaly at Bristol to test for supergene gold and to determine the bedrock geology. Figure 1 shows the location of the RC drill holes from the Bristol programme.

The gold anomalism occurs on a distinct magnetic (and gravity) gradient, a setting that is often associated with gold mineralisation.



Ascalon:

Initial drilling at Ascalon has identified a north-west striking and east dipping hydrothermal system that is interpreted to have a potential strike length over 2,000m. It remains open to the north, south and most importantly to the east where higher levels of gold were intersected.

Three major, geochemically-distinctive alteration events can be interpreted from the logging and assay results, and are sequentially developed from west to east.

Alteration Zone 1 appears to define the western boundary of the prospective mineral system at Ascalon, and may act as a control on potential gold mineralisation in the eastern part of the system.

Alteration Zones 2 and 3 are open to the north and south along strike, with no other drilling for over 1,500m in either direction. These zones are also open at depth, and Zone 3 is also open to the east. Alteration Zones 2 and 3 are prospective for PGEs and gold mineralisation.




Figure 2 – the Ascalon target shown against magnetic data with Alteration Zones and follow-up drilling highlighted.

One important area for further drilling is the large magnetic low that lies immediately north-west of the ASCRC001 to ASCRC005 drill section. Figure 2 highlights this area and the ten drill holes to be completed in the drill programme underway.

The magnetic low may represent a more intense area of hydrothermal alteration where hydrothermal fluids have destroyed the iron-rich minerals in these mafic rocks, and may have associated gold mineralisation. The siliceous alteration in the central zones of Orogenic gold systems typically present as magnetic lows within more magnetic country rocks.




Figure 3 – the main gold-bearing greenstone belts of the Yilgarn Craton, showing the East Laverton Project in the under-explored eastern margin of the North Eastern Goldfields where Tropicana and Gruyere - two of the most recent and significant gold discoveries in Australia are also located.
